

The highlights of this release are:

- State Direct Business Name Searches – Data for most states will be completely current
- Create a Filing from a Business Name Search – Save time and prevent typing errors by using your search to create a filing

State Direct Business Name Searches

State Direct is now available for the Business Name Search from the Home or Filing pages and for the Business Entity Information Name Search from the Search Public Records page. The most current data from the states is used for State Direct, and all states are available except for Alabama, Virginia and Wisconsin, which will continue to use the iLien data.

All of these searches will be saved in the Search/Order Portfolio. The design of the Business Name Search from the Filing pages has been changed to match the other pages and “Business Entity Information” will be used as the Search Type in the Portfolio.

The available data and format may vary from the iLien database searches and may also vary from one state to another.

Since there are additional fees for New Jersey, Oklahoma and Texas, your default Search/Order Preference for the Business Name Search will be to “Use State Direct, when available, for states with no additional fees.” When this Preference is selected, the iLien database search will be used for the states with additional State Direct fees.

The additional detail record fee for New Jersey and Oklahoma is \$5.00 per record. State Direct searches for Texas will incur a \$1.00 for summary records and a \$1.00 per detail record. These fees can change at any time.

There are no data or fee changes for Delaware. The data for Delaware has always been retrieved directly from the state’s system, and there will still be a search fee for each detail record.

The other preferences which can be selected are “Use State Direct, when available, for all states” or “Use iLien data for all states.”
